

PRIVACY POLICY of TREVENTUS Mechatronics GmbH

This policy together with any other documents (e.g. TREVENTUS terms) referred to in it sets out the basis on which any personal data we collect from you, or that you provide to us, will be processed by us. We process your data exclusively on the basis of the legal regulations in accordance with the General Data Protection Regulation (GDPR) (EU) 2016/679 with regard to the processing of personal data (the "GDPR") as well as all other binding standards in the respectively valid version).

In this privacy policy we inform you about the most important aspects of data processing of TREVENTUS Mechatronics GmbH, Siebenbrunnengasse 17/2, 1050 Vienna (hereinafter referred to as "TREVENTUS"). For the protection of your data, we therefore use only the most modern security standards.

Please read the following carefully to understand our views and practices regarding your personal data and how we will treat it.

INFORMATION WE MAY COLLECT FROM YOU

We may collect and process the following data about you:

- Information that you provide by filling in forms on our site https://www.treventus.com/special-pages/inquiry.html. This includes information provided at the time of registering to use our site, subscribing to our service, posting material or requesting further services. We may also ask you for information when you report a problem with our site.
- If you contact us, we may keep a record of that correspondence.
- We may also ask you to complete surveys that we use for research purpose, although you do not have to respond them.
- Details of transactions you carry out through our site and of the fulfilment of your orders.
- Details of your visits to our site including, but not limited to, traffic data, location data, weblogs and other
 communication data, whether this is required for our own billing purposes or otherwise and the resources that
 you access.

NEWSLETTER

You have the option of subscribing to our newsletter via our website, by registering via a form or by leaving your personal e-mail address. For this we need your e-mail address and your declaration that you agree with the subscription to the newsletter. As soon as you have registered for the newsletter on our homepage, we will send you a confirmation e-mail with a link to confirm the registration. Only when the confirmation takes place will the e-mail address be included in the mailing list.

The newsletter is sent through TREVENTUS by using the provider Newsletter2Go. The provider of this service is Newsletter2Go GmbH, Nürnberger Straße 8, 10787 Berlin, Germany. There is no data transmission to a third country (outside the EU).

Newsletter2Go is a service which organizes and analyzes the distribution of newsletters. The data you provide to subscribe to our newsletter will be stored on Newsletter2Go servers in Germany.

COOKIES AND WEB-ANALYSIS

We may collect information about your computer, including where available, your IP address (by automatically deleting the last 8 bits of your IP-address), operating system and browser type, for system administration. This is statistical data about users'browsing actions and patterns and does not identify any individual. For the same reason, we may obtain information about your general internet usage by using a cookie file which is stored on the hard drive of your computer. Cookies contain information that is transferred to your computer's hard drive. They help us to improve our site and to deliver a better and more personalized service. They enable us:

- To estimate our audience size and usage pattern.
- To store information about your preferences, and so allow us to customize our site according to your individual interests.
- To speed up your searches
- To recognise you when you return to our site.

A combination of this data with personal data sources will not be made. We reserve the right to check this data retrospectively, if we become aware of specific indications for illegal use.

Our website uses features of the web analytics service Google Analytics by Google LCC, Mountain View, California, United States of America. The relationship with the web analytics provider Google LLC is based on the "Privacy Shield" 2006 agreement. Cookies are used to analyze the use of the website by your users. The information generated thereby is transmitted to the server of the provider and stored there.

You may refuse to accept cookies by activating the setting on your browser which allows you to refuse the setting of cookies. However, if you select this setting you may be unable to access certain parts of our site. Unless you have adjusted your browser setting so that it will refuse cookies, our system will issue cookies when you log on to our site. In addition, you may prevent the collection by Google of the data generated by the cookie and related to your use of the website (including your IP address) as well as the processing of this data by Google by using the link below (https://tools.google.com/dlpage/gaoptout?hl=en) to download and install the available browser plugin.

Your IP address will be recorded but pseudonymized immediately by deleting the last 8 bits with the option "anonymizeIP". As a result, only a rough localization is possible. As a rule, your IP address will be shortened beforehand by Google within member states of the European Union or in other contracting states of the Agreement on the European Economic Area. Only in exceptional cases will the full IP address be sent to a Google server in the US and shortened there. The IP address provided by Google Analytics as part of Google Analytics will not be merged with other Google data.

Our concern in the sense of the GDPR (legitimate interest) is the improvement of our offer and our website. The user data is kept for a period of 26 months.

TLS ENCRYPTION WITH HTTPS

We use https to transfer data securely on the Internet. By using TLS (Transport Layer Security), an encryption protocol for secure data transmission over the Internet, we can ensure the protection of confidential data. You acknowledge the use of this security of data transfer at the small lock symbol in the upper left corner of the browser and the use of the https scheme as part of our Internet address.

GOOGLE MAPS

We use Google Maps from Google Inc. (1600 Amphitheatre Parkway Mountain View, CA 94043, USA) on our website. By using the features of this card, data will be transmitted to Google. DATA SECURITY AND WHERE WE STORE YOUR PERSONAL DATA
